PARTICIPATION AGREEMENT

I, the parent/guardian of the participant named below, hereby acknowledge that my child is in good general health and I give my approval for my child to participate in all BYCA activities. I am fully aware of the potential dangers of participation in any sport and I fully understand that participation in cheerleading may result in serious injury. I hereby understand and agree that BYCA, it's members, coaches, or officers shall not be held liable for any injury or loss that my child may sustain while participating in BYCA activities of any kind, and I agree to hold harmless the BYCA, it's members, coaches, or officers of any claim whatsoever.

EMERGENCY MEDICAL AUTHORIZATION

I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all BYCA activities.

EQUIPMENT RESPONSIBILITY

I agree to assume responsibility for all uniforms purchased to the participant named below and I agree to keep my uniform in good condition throughout the entire season. If I fail to adhere to this policy, I will be responsible for the replacement cost of such equipment.

INSURANCE DISCLOSURE

I am aware that BYCA carries group accident insurance which is considered secondary or excess for medical purposes to any and all valid insurance I possess. I understand that any registration fee paid does not constitute a direct premium for insurance and that a deductible(s) may apply.

FINANCIAL RESPONSIBILITY

I hereby acknowledge that I have been advised by BYCA of my financial responsibility. I understand that if my child withdraws for any reason, NO REFUNDS for football only cheerleaders will be issued after Fittings and NO REFUNDS for competition cheerleaders will be issued after First Practice. I have also been advised of my fundraising obligations for the season and agree to fully comply with those obligations.

RULES & REGULATIONS

I hereby acknowledge that as a parent/guardian of a BYCA participant it is my responsibility to comply with all rules/regulations of BYCA and/or its coaches, including the Code of Conduct. Non-compliance with any rules/regulations may be cause for discipline and/or dismissal of my child or me. I understand that any individual dismissed from the organization will not be reimbursed for any fees paid.
